- I. Announcements²
- II. Current projects: status reports³
- 1 C. Whitehead arrives 9:05 am, reports traffic backed up over the bridge and personal parking space already taken. General appearance tired, harassed. Departmental meeting convenes at 9:15.
- 2 Update on operating system upgrade by T. Howe and H. Tate. Monthly reminder about company policy on common-area microwaves and refrigerators. Request for special event posters to be cleared by department receptionist/admin assistant before posting.
 - **Discussion**: B. Goldfarb points out that Christmas holiday party posters do not require clearance, but a flyer about Passover seder at the Mittleman Center apparently does. C. Whitehead denies underlying bias to policy. V. Farmer [intern] affirms appearance of bias, without confirming intention of bias. V. Farmer also comments that she is Jewish on her father's mother's side, and loved *Schindler's List*.
- T. Howe and H. Tate report on IT equipment inventory project. Complete inventory of non-capitalized IT equipment is due 4/1. Request responses to emailed requests for information about workstation setups. J. Simmons asks if mice count. T. Howe and H. Tate: no, mice do not count.
